The RSPCA Million Paws Walk

Million Paws Walk (MPW) is the RSPCA's most established and well-known national fundraising event. MPW is primarily a fundraising event that also provides an opportunity to promote responsible pet ownership. In 2014, there were over 100 walks held across Australia with over 50,000 participants. In 2015, Queensland will host walks in more than 20 regional areas with a capital city walk held at Southbank Parklands.

Million Paws Walk is held on the 3rd Sunday of May every year. It is a fantastic event where pet owners can participate in a healthy walk, mingle with other pet owners and learn more about responsible pet ownership and the latest innovations in animal care from the many exhibitors at each walk.

Participants can walk and fundraise as individuals, families or as teams. Million Paws Walk is more than a day out for your favourite four-legged friend; it is a festival designed to entertain, inform and educate. Aside from the walk itself, activities, attractions and entertainment will be scheduled throughout the day to entice participants to stay and enjoy a day out with their pet.

Key features of the day include

- 3km—5km structured walks with pet water stops
- Pet expo featuring the latest pet products and services
- Food and beverage stalls
- Live entertainment
- Celebrity guests
- Agility canine courses and demonstrations
- Competitions
- Vet checks
- Dog washing

The Audience

In 2015, we are expecting approximately 10,000 people to attend the walk at Southbank Parklands. Our audience is made up of families, young professionals, students and social groups— all of whom love their dogs.





The Venue

In 2015, Million Paws Walk will take place on Sunday 17th May at Southbank Parklands, opening at 8.30am. Walkers and their pets meet at the Cultural Forecourt, Southbank Parklands where the main event village will be, they will be able to enjoy the festival atmosphere before starting their walk at 10.00am and finishing up back in the event village.

After the walk, the festivities continue. Participants can enjoy lunch and beverages from the many food and drink outlets, relax in the sun watching stage entertainment, participate in a canine obstacle course and visit the expo stands. A series of competitions will also be running throughout the day.

Food Exhibitor Requirements

Food licence and public liability insurance

All food exhibitors must hold a current food licence and supply RSPCA Qld with a copy. In addition to this, a copy of your public liability insurance to a minimum of \$10,000,000 is required to exhibit at Million Paws Walk.

RSPCA's Humane Food Policy

As an animal welfare organisation, all food products must adhere to our Humane Food Policy. Whilst accepting that animals are used for food production, the RSPCA is opposed to all forms of farming that cause injury, suffering or distress to animals, or which unreasonably restrict their movements and behaviour. As a result, the RSPCA sets high standards for the welfare of all animals in farming systems. Below is a brief outline of meat and egg products permitted at RSPCA Qld events however please refer to the enclosed Food Policy for a complete overview.

• Eggs have not been produced in cages. Instead, choose eggs that are from a cage-free system, such as 'RSPCA Approved Farming Scheme' Eggs or free range eggs.



- Pork products (eg ham & bacon) have not been produced in intensive farming systems using farrowing crates and sow stalls. Instead, look for products that are approved by the RSPCA, such as 'RSPCA Approved Farming Scheme' pork. Alternatively, choose free-range pork products.
- Any food not sourced from an RSPCA Approved Farming Scheme (such as chicken or lamb) is not from an intensive farming system which closely confines the animals but, rather, uses a free-range system, and otherwise meets best practice for farm animal management. Australian certified organic products and NASSA products are examples of products produced following humane animal production practices.
- Vegetarian and vegan options are available for those staff, volunteers and members of the public who choose not to eat meat, egg or dairy products for ethical reasons.
- Ethical food choices are not compromised to save money.

Infrastructure requirements

Due to Occupational Health and Safety requirements, all food and beverage stalls are required to have a roof and flooring. Marquees and pro-flooring are available for hire. These are mandatory requirements, issued by Brisbane City Council.

Exhibitor fees

Food exhibitors at Million Paws Walk are offered discounted fees to assist us in better serving participants by providing a range of food and beverage options. Exhibitor fees are listed on page 6.

Million Paws Walk is RSPCA's largest fundraising event of the year and we would love for you to donate a percentage of proceeds back to RSPCA to assist us in our fundraising efforts if you are in a position to do so. For instance, you could donate 50% of proceeds or \$2 from every item sold. If you decide to do this, we encourage you to display signage to show your generous support on the day. Benefits may include;

- The profiling of your business supporting RSPCA Qld to 10,000+ participants.
- Corporate social responsibility increase your profile in the community. Research has shown that customers are more likely to purchase from companies that support charities.

SUB-LEASING: Under no circumstances is any exhibitor to sub-let space to another organisation, individual or business.

RESTRICTED ITEMS: Exhibitors can NOT sell food or beverage for human consumption from their stall without prior consent from RSPCA Qld. All food and beverage must adhere to standards outlined in the 'Humane Food Choices' brochure provided to you. Due to existing national sponsorship agreements no major pet food products may be sold (certain pet treats excepted). RSPCA reserves the right to refuse the presence of any products, information or services that they deem to be inhumane or harmful to animals or contradict RSPCA's Five Freedoms (www.rspcaqld.org.au/aboutus/freedoms).

OH&S: Exhibitors are expected to follow best practice safety standards and abide by OH&S regulations to ensure the event is safe and compliant at all times. Staff training will be the responsibility of the exhibitor.

STALL INFORMATION: Exhibitors agree to the guidelines detailed in this document relating to turf protection, signage, exhibitor display, promotion and equipment hire.

TIMINGS: Exhibitors agree to comply with the bump in and out schedules allocated to them.

STAFF: Exhibitors agree to provide adequate staff to run their stall (up to 4 staff)

WASTE: Exhibitors agree to comply with rubbish removal procedures as outlined in this document.

INDEMNITY: Exhibitors participate in Million Paws Walk at their own risk and agree not to hold the RSPCA, its employees, agents, sponsors and independent contractors liable in any way for injury to you or your staff or loss or damage to your personal or third party property in connection with this event. You agree to indemnify the RSPCA for any claim brought against it, its employees, agents, sponsors and independent contractors by any third party for any loss or damage arising from any breach of duty by you. This includes, but is not limited to, loss or damage caused by breaches of duties that would otherwise be imposed in tort or contract but for this clause.

INSURANCE: Exhibitors MUST provide a current copy of their Public Liability Certificate with their application. Coverage must be valid for the event date with insurance to a minimum of \$10 million.

PAYMENTS, REFUNDS & CANCELLATION

- RSPCA Qld reserves the right to refuse any application that does not meet all criteria outlined within this document.
- Payment must be made <u>in full</u> at the time of application; no part payment will be accepted. No application will be accepted without full payment. Payment will not be processed until application has been approved.
- Payments are non-refundable unless the event is cancelled by RSPCA Qld. RSPCA Qld reserves the right to cancel the event due to uncontrollable circumstances such as terrorist threat, force majeure and extreme bad weather.
